Grant Application Deadlines & Commission Meeting Dates for 2018 General Assembly Office Elections

Pursuant to General Statutes § 9-706(g)(1), weekly grant application deadlines fall on Wednesdays (except where a state holiday occurs) and the Commission has five business days to review General Assembly applications and make a grant determination.
