***I. Call to Order***

Commissioner Stephen Penny was present via Webex and called the meeting to order at 9:34 A.M. Commissioners Michael Ajello, Salvatore Bramante, Shannon Bergquist and Andrew Cascudo were present via Webex. Agency staff was also present.

***II. Approval of the Minutes***

*Approval of the Minutes of the Meeting of March 17, 2021*

***III. Administrative Reports***

Michael Brandi reported that we are entering into the final quarter of the fiscal year. Right now we are looking at the last quarter to which we are making sure that we have supplies and equipment necessary to remote work. We just purchased additional laptops and software. Budget wise we are in good shape for the balance of the year. There's no anticipated shortfalls and we should be able to finish by June 30<sup>th</sup> with a positive balance.

Michael Brandi updated that regarding personnel – Ron Perry has joined the SEEC as legal investigator, Paul Brady has joined us as a new Elections Officer and an additional Elections Officer will be joining us on April 23<sup>rd</sup>. That will leave 3 vacancies left in the agency, we have a Fiscal Administrative officer position which we are in the process of filling with interviews starting next week, so we hope to fill that one rather quickly. We are working right now Accounts Examiner position which has been vacant since November of last year and hope to fill that by the end of this fiscal year.

We will be back up to a compliment of 34 out of 35 positions at the end of the hiring process.

We have a legislative report we are in the midst of what seems to be an active legislative session. The GAE committee has completed their meetings reported all of their bills to the floor. There are multiple bills heading to the floor including the childcare bill, which was the Governor's proposal. The bills regarding disqualified contributions and deregulation of internet sites did not get voted out of committee.

When the house and the senate are in session SEEC will actively keep our eyes on those bills to make sure that there are no surprises later in the session.

Other bills we will be watching are related to absentee ballots and more elections administration, nothing that directly impacts our jurisdiction, other than the enforcement side. SEEC will continue to monitor the floor, it is not uncommon for things to suddenly appear in other bills, so we will continue to monitor these bills.

Michael Brandi advised that the current Governor's executive orders as it governs these meetings, will expire on May 20<sup>th</sup>. The SEEC will be looking to return to live meetings beginning with the first meeting in June. We don't think that they will be extending those executive orders related to virtual meetings beyond that date. So commissioners should just be prepared for coming to the new office.

Commissioner Bergquist asked about what types of items go into the budget. Specifically, where do disqualified contributions get deposited. Do those go into the SEEC budget or the Citizens' Election Fund? Director Brandi clarified that the SEEC budget is an operating budget comes solely from the general fund. The issue of disqualified contributions or buffers or any monies that come in in relation to the CEP program those monies go into the Citizens' Election Fund and the only thing that comes out of the fund are grants. The idea that SEEC is able to take money out of the Fund to fund our operations is simply false. When the program was first founded, there were operating expenses that were taken from the Citizens' Election Fund to fund certain positions and operations. That ended by statute in 2009. Since 2009 no funding for the agency operations comes from anything but the General Fund.

Commissioner Bramante asked about the agency surplus expected by the end of the fiscal year, does that go back to the general fund? Yes, that is correct. SEEC has to close out the books by June 30<sup>th</sup>. The agency has a single line budget, which means the agency is free to use this money for personnel and operating costs. At the end of the fiscal year, all monies in every agency that have a surplus are returned to the general fund.

Director Brandi advised of two amendments to the agenda: Item #1 in public session will be moved to executive session. Adding to executive session File No. 2020-052 as item #7.


