**I. Call to Order**

Commissioner Castagno was present via Webex and called the meeting to order at 9:47 A.M. Commissioners Salvatore Bramante, Stephen Penny and Andrew Cascudo were present via Webex. Agency staff was also present via Webex.

**II. Approval of the Minutes**

*Approval of the Minutes of the Meeting of November 18, 2020*

It was moved by Commissioner Bramante and seconded by Commissioner Penny to approve the November 18, 2020 minutes with minor word changes to the Administrative report by a 4-0-0 vote. So voted.

**III. Administrative Reports**

Director Brandi updated the Commission on the budget. The SEEC has moved to the new location from Trinity Street to 55 Farmington Ave, in Hartford, CT. the entire Agency moved on December 18<sup>th</sup>, 2020. Staff are settling at 55 Farmington Avenue, but there's still a little more to be done but the office is functional, up and running.

Director Brandi Shared a budget update with the Commission on the agency's budget. Currently there are vacancies, which allowed extra budget money. Brandi shared that the SEEC has 2 positions open and in the process of hiring and interviewing. Staff hopes to fill those positions within the next month.

Director Brandi shared that we are about to embark into Inauguration Day would like to say congratulations to President Elect Biden and Vice President Elect Harris. Most of staff is working remotely today due to safety concerns. The new building is very secure, however a memorandum from the Governor's Office was distributed instructing to take precaution today.

Director Brandi shared that staff is looking at the beginning session that's starting a very different session. Leadership has changed with a New Speaker and Minority Leaders in the house. The hardest part of this legislative session is the capital complex is still effectively closed and everything is done remotely including all the hearing for the GAE Committee.

Director Brandi shared updates on the proposed legislation. Staff will be reviewing and preparing some proposed legislation including a technical bill this year. The Agency is waiting to see what transpire at the Capitol during session, but the whole staff is prepared at this point. Staff is ready to address any bills that are coming forward that will involve the SEEC and we do expect the major focuses this session will be on early voting. Also, there is a special election coming up for a senate seat in the 27<sup>th</sup> district so, we anticipate the Governor issuing emergency orders there to allow for continued early voting process that was used in general election in November and in the Primaries back in August.


**VII. Adjournment**
