MINUTES STATE ELECTIONS ENFORCEMENT COMMISSION REGULAR TELEPHONIC MEETING

1st Floor Conference Room March 3, 2021 9:30 A.M.

I. Call to Order

Commissioner Penny was present via Webex and called the meeting to order at 9:36 A.M. Commissioners Salvatore Bramante, Anthony Castagno, Michael Ajello and Andrew Cascudo were present via Webex. Agency staff was also present via Webex.

II. Approval of the Minutes

Approval of the Minutes of the Meeting of February 17, 2021

It was moved by Commissioner Bramante and seconded by Commissioner Ajello to approve the February 17, 2021 Minutes by a 3-0-2 vote. Commissioners Ajello and Cascudo abstained. So voted.

III. Administrative Reports

Director Brandi reported on a couple of issues related to the Legislature. SEEC has completed the initial appropriations hearing which went well. They were very few questions related to our budget for the next two years since our budget is effectively a flat budget.

Director Brandi reported the Appropriations hearing was done via Zoom this year, which was a different format from prior years. A sub-committee meeting is coming up in the next few weeks and SEEC staff will advise of any issues that arises from that meeting.

Questions usually asked of the agency include the status of vacancies and potential retirements. Also, there was a question as to the sufficiency of the fund looking into the 2022 statewide elections. SEEC was able to report on the funds and at this point, the fund is right on track. This is due largely to the 2018 statewide election candidates participating in the CEP, but the eventual gubernatorial candidates did not participate. This was an overall saving for the CEP budget.

Director Brandi advised that the 2022 SEEC budget is on track with the amount of money in the fund. There are over 22 million dollars in the fund presently with

additional deposits that will be made by statute following the adoption of the new budget moving forward.

Director Brandi reported in terms of SEEC vacancies, human resources is in the process of filling our two vacant Election Officer positions. Ron Perry, the SEEC's new Legal Investigator is on board and present today. SEEC also anticipates filling one Fiscal position and an Accounts Examiner in the next weeks. This will increase the total number of staff to 34 of the 35 positions. We hope to complete the hiring process for these positions in the next six to eight weeks as soon as we get through all the process with DAS and approval that is required from DAS and OPM.

Director Brandi reported that staff continues to do a great job. Managers are working remotely with a schedule of 2-3 days a week of office time with all other staff working remotely. Staff has a weekly office schedule with rotating days while we are working to maintain our COVID- 19 safety measures.

Director Brandi advised that SEEC staff is monitoring bills in the CT legislature affecting the agency and campaign finance laws in general. SEEC is also monitoring nationally the H.R.1 bill at the House of Representatives. Of interest is Public Campaign Financing on a federal level or a matching grant program. Also, SEEC staff is monitoring Voter suppression bills that are being filed now nationally and monitoring to see how the impact would affect us in Connecticut.

Director Brandi Reported of upcoming Conferences for Town Clerks and registrars. These conferences will be virtual and one of the topics will be the bill in Connecticut that is related to the Constitutional Amendment to pass the early voting and changes to the Absentee ballots.

Director Brandi reported on discussions with leaders of the legislature. Some of the discussions were about education and getting the word out there that our elections are safe and secure showing the data that we have reflecting such. A part of the SEEC's mission going forward in the next few months includes restoring confidence in the electoral system. As the Agency responsible for investigating and prosecuting claims of election fraud, voter fraud, and irregularities at the Polls, the SEEC has the advantage of the data and expertise that's here. We need to publicize the data which will show Connecticut does a great job; ballots are tabulated and the misinformation that's rampant still about voter fraud is inaccurate.

Director Brandi reports there are 30 of the 2018 election Audits prepared for final today. SEEC staff is working on completing the balance of the 2018 Audits. Then, we are moving towards the review of the 2020 election cycle and trying to move forward with those projects as far as we can as we get into the Municipal Cycle this year.
