I. Call to Order

Commissioner Castagno was present via Webex and called the meeting to order at 9:34 A.M. Commissioners Salvatore Bramante and Stephen Penny were present via Webex. Agency staff was also present via Webex.

II. Approval of the Minutes

Director Brandi reported that the Governor's budget has been submitted. Has passed through our requested budget. Our budget hearing will be Monday at 11:30 AM to which we are preparing testimony.

Director Brandi reported starting February 26th Ronald Perry will be starting with the agency. He is a former detective with the City of New Haven Police Department.

Director Brandi reported we are holding Election Officer interviews this week. We currently have 2 open positions, but we will be filling 1 at this time.

Director Brandi reported Staff is still maintaining schedules and working remotely. We will continue to maintain this framework for as long as necessary.

Director Brandi advised-we are monitoring appropriations and the GAE committees. They were several bills that were affecting us. The most common involved

constitutional amendment on Absentee Ballots and continuations of early voting for any special elections under the Governor's powers.

The SEEC has seen a few bills relating to the CEP. Most likely the bills are supposedly related to the childcare case which went up to the Superior Court. We are waiting for additional bills to come forward relating to CEP contributions. The contribution bill involve returning buffer amounts from disqualified contributions. We anticipate additional GAE and Appropriations meetings in the next few weeks.
