***I. Call to Order***

Commissioner Penny was present via Teams and called the meeting to order at 9:31 A.M. Commissioners Sonia Worell Asare, Shannon Bergquist and Greg Piecuch were present via Teams. Agency staff were also present and present via Teams.

***1. Report of Executive Director and General Counsel Ryan Burns***

Executive Director Burns gave an abbreviated report as the Commission's quarterly in-person meeting concerning administration and operations is scheduled for April 8<sup>th</sup>, 2026. Director Burns did report that the United States Department of Justice was successful in their prosecution of former Senator Dennis Bradley. That matter that was initially investigated by our office and concerned misrepresentations in order to receive a grant from the Citizens' Election Program. As the case has not gone through sentencing Director Burns urged caution about making any comments about the substance of the case, but did want to extend the Commission's deep gratitude to the Department of Justice, the United States Attorney United States Attorney's Office for the District of Connecticut and the Federal Bureau of Investigation for their efforts over many years to prosecute this case. Director Burns also wanted to recognize all the hard work of the staff, both former and current, that worked on this case. Director Burns specifically recognized Richard Bramande and Sheri-Lyn Lagueux who provided valuable testimony in the case in that case. Investigator Lagueux's contributions were specifically highlighted as her testimony extended over three

days and her contributions as a witness in preparation had occurred over the several years that this case was pending.
