Commissioner Penny was present via Webex and called the meeting to order at 9:31 A.M. Commissioners Shannon Bergquist, Michael Ajello and Greg Picuch were present via Webex. Agency staff were also present and present via Webex.

Executive Director and General Counsel Ryan Burns reported several updates to the Commission. On the human resources front, we welcome Zak Jazlowiecki back from leave. We have completed the application process for our final vacancy, the Accounts Examiner position, and we look forward to beginning interviews shortly.

Director Burns discussed the enforcement docket, which currently includes 182 total cases. This caseload encompasses non-filer matters, cases in collection, and those otherwise pending. Of these, 45 are non-filer matters, and 108 are active investigations or prosecutions. On the Citizens' Election Program (CEP) grant application side, there is only one pending matter, which will be addressed later in today's meeting.

Director Burns stated that our IT team has been working closely with the audit and compliance teams to develop new tracking mechanisms that will ensure applications move through the process in a timely manner. They are also implementing automation for certain grant receipt processes to improve efficiency and consistency across the board.

Director Burns stated we continue to prioritize the review of older audits. Our goal remains to have all audits completed prior to the 2026 grant season.

Director Burns said that he held a productive meeting with representatives from the U.S. Attorney's Office for the District of Connecticut and the Chief State's Attorney. These relationships remain strong, and we are working on strategies to ensure compliance with election laws. We are also planning a meeting with the Election Security Task Force, which includes federal and state law enforcement as well as civil participants in the election process.
