I. Call to Order

Commissioner Stephen Penny was present via Teams and called the meeting to order at 9:30 A.M. Commissioners Michael Ajello, Sonia Worell Asare, and Shannon Bergquist were present via Teams. Agency staff were also present via Teams.

1. Report of Executive Director and General Counsel Ryan Burns

Executive Director and General Counsel Ryan Burns provided an abbreviated report on legislation. Legislative updates regarding the Fire Districts bill, which was referred to the Appropriations Committee, however, at their most recent committee meeting, they failed to vote it back to the floor. The Municipal Election Review Board bill, was voted out of committee and has come out of both GAE and Appropriations with favorable reports. Finally, the one bill most likely to get a favorable vote is HB 5001, which includes the universal absentee

balloting provisions. There was a fiscal note added to include one investigator for this office. This is moving through and will be voted on by Appropriations on Friday. This bill is almost certain to pass in some form this session.
