***I. Call to Order***

Commissioner Penny was present via Teams and called the meeting to order at 9:31 A.M. Commissioners Sonia Worell Asare, Shannon Bergquist and Greg Piecuch were present via Teams. Agency staff were also present and present via Teams.

***II. Approval of the Minutes***

*1. Approval of the Minutes of the Meeting of April 15, 2026*

It was moved by Commissioner Bergquist and seconded by Commissioner Piecuch to approve the Minutes of the Meeting of *April 15, 2026*. So voted by a vote of 4-0-0.

***III. Administrative Reports***

*1. Report of Executive Director and General Counsel Ryan Burns*

Executive Director Burns provided an update on staffing. Sherida Shepherd has joined the agency on a temporary basis through the end of the summer to support the processing of applications. Her prior experience with the DPH/CEP team is expected to improve workflow efficiency.

Executive Director Burns reported that the 2026 legislative session concludes today. A full legislative report will be presented at the May 20, 2026 meeting. At this stage, the session has been largely successful, with no significant changes anticipated for the 2025–2026 election cycle. Bill 5001 passed the House earlier in the session and awaits action by the Senate.

Executive Director Burns advised that the state budget enacted on Saturday includes a \$3.5 million sweep from the Citizens' Election Fund. This reduction may create funding challenges, particularly given the increased grant amounts for the 2026 cycle, including gubernatorial grants. While statutory overdraft protection ensures continued administration of the program, the fund may reach a

tight margin. Legislative leadership has been informed of these concerns. The Commission was briefed to ensure awareness as upcoming grant applications may place additional pressure on the fund.

Executive Director Burns reported that the agency currently has 193 active enforcement matters, comprising 50 non-filer cases, 35 criminal referrals, and 108 additional complaints, referrals, or SEEC-initiated matters. The recent increase is partly attributable to audit referrals issued at the previous meeting. Audit work is nearly current, with no significant audit batches anticipated until the next election cycle. Between 12 and 24 special election audits remain outstanding; staff will present a comprehensive plan for their completion in June.

Executive Director Burns updated that a total of 69 candidate committees are in some stage of pre-application review. Of these, 47 have been pre-qualified, including two gubernatorial committees. Despite unusually high grant activity for this point in the cycle, the agency has made substantial progress due to the significant efforts of staff. What could have been unmanageable has become manageable due to the team's exceptional effort. I want to acknowledge and thank the staff for their hard work.


