I. Call to Order

Commissioner Penny was present via Teams and called the meeting to order at 9:31 A.M. Commissioners Michael Ajello, Shannon Bergquist, Greg Piecuch and Sonia Worell Asare were present via Teams. Agency staff were also present and present via Teams.

II. Approval of the Minutes

1. Approval of the Minutes of the Meeting of May 28, 2026

It was moved by Commissioner Ajello and seconded by Commissioner Bergquist to approve the Minutes of the Meeting of *May 28, 2026*. So voted by a vote of 5-0-0.

III. Administrative Reports

1. Report of Executive Director and General Counsel Ryan Burns

Executive Director Burns reported that staff across Compliance, Candidate Services, and audit units have been extremely busy launching this year's CEP season, made more challenging by new Public Act 25-26 requirements. Despite the workload, candidates and treasurers have offered unsolicited praise, and staff efforts are formally commended.

Executive Director Burns updated that in Enforcement, there are 180 pending enforcement matters: 49 non-filers, 36 referrals on hold, and 102 complaints, referrals, and SEEC-initiated investigations. No general election audits are outstanding, and none are expected before March 2027. Work on Special Election Audits continues, with a full memorandum expected in two weeks.

Executive Director Burns advised that the agency has received 43 grant applications this season; 2 were previously approved, and 18 are up for

consideration today. In total, this represents 6–8% of total grant applications and reflects extensive preseason PAR preparation and strong staff diligence.

Executive Director Burns reported that audit lottery regulations are under review by the Attorney General's Office, with feedback expected within one to two weeks. As this is the second submission with prior comments addressed, the process is expected to progress smoothly once the formal response is received.

Executive Director Burns updated that the Fiscal team is managing year-end purchasing, expenditures, and legislative salary adjustments, including retroactive payments, while supporting grants, disbursements, and uninterrupted payroll.

Executive Director Burns advised that IT staff are updating decade-old document scanning systems that are no longer interfaced with upgraded agency systems. Integrating new hardware and software has been more complex than anticipated. IT simultaneously supports fiscal closeout and assisting staff agency-wide.
