



## SEEC Grant Application Deadlines & Commission Meeting Dates for 2022 General Assembly Office Elections

***Pursuant to General Statute § 9-706 (g) (1), weekly grant application deadlines fall on Wednesdays (except where a state holiday occurs) and the Commission has five business days to review General Assembly applications and make a grant determination.***

### Primary Grant Applications Will Not Be Accepted After July 15<sup>th</sup> at 5 p.m.

\*Note: During the “primary blackout period” (beginning after 5:00 p.m. on July 6 and going through 5:00 p.m. on July 13) candidates not facing a primary may still submit applications for general election grants, but the applications will be deemed as received for the July 20 application deadline, and the Commission will not make a grant determination on such general election applications until its July 27<sup>th</sup> meeting.
