Grant Application Deadlines & Commission Meeting Dates for 2024 General Assembly Office Elections

Pursuant to General Statutes §9-706(g)(1), weekly grant application deadlines fall on Wednesdays (except where a state holiday occurs) and the Commission has five business days to review General Assembly applications and make a grant determination.

Primary Grant Applications Will Not Be Accepted After 5 p.m. on July 19th

*Note: During the “primary blackout period” (beginning at 5:00 p.m. on July 10 and ending at 5:00 p.m. on July 19) candidates not facing a primary may still submit applications for general election grants, but the applications will be deemed as received for the July 24 application deadline, and the Commission will not make a grant determination on such general election applications until its July 31 meeting.
