I. Call to Order

Commissioner Penny was present via Webex and called the meeting to order at 9:32 A.M. Commissioners Michael Ajello, Stephen Penny and Anthony Castagno were present via Webex. Agency staff was also present.

II. Approval of the Minutes

Approval of the Minutes of the Meeting of March 3, 2021

It was moved by Commissioner Ajello and seconded by Commissioner Castagno to approve the Minutes of the Meeting of March 3, 2021. So voted by a vote of 4-0-0

III. Administrative Reports

Director Brandi reported that budget wise we are in the process of being reviewed by the Appropriations Committee. Because of the nature of the remote Zoom access for so many members of the Legislature, SEEC was contacted by OFA and the subcommittee determined that there was no need for a workshop with the agency. There was really no change to the budget, but at this point in time SEEC will just be waiting on general appropriations to come out with the budget for approval.

Director Brandi updated that in terms of our positions, we have been trying to refill our ranks with the vacancies the agency has had. SEEC recently filled the Legal Investigator Position, so Ron Perry, who is on the livestream today with us, joined us a few weeks ago. SEEC recently filled two elections officer positions we expect one starting on the 26th of March and one shortly thereafter. SEEC is also in the process of filling a fiscal position here at the agency which has been posted and we hope to begin those interview in the next two weeks. The final position we are going to hire will be for an Accounts Examiner. Once filled, the SEEC will be back up to approximately 34 out of the 35 authorized positions within the next two months. That will get us a lot of lead time for training for the Municipal cycle that's starting as well as getting ready for the 2022 Statewide cycle.

Director Brandi advised that audits are going very well, we are trying to finish up a lot of the 2018 General Assembly as well as the Statewide Audits Linda's group has switched back over to handling those parts of the process.

Director Brandi updated that there are a lot of Special Elections going on right now, including one CEP application for today. Commissioners should be prepared for a special meeting within the next week as there is a second application we are expecting. There is another special election for the Stamford District, House 145 as Patricia Billie Miller won for Senate 27 and her seat is now open. So we expect more applications for CEP in that special election.

Director Brandi reported that the SEEC is trying to work on lots of different pieces for upcoming events. SEEC will be attending the Town Clerk's convention, and there is another event coming up in April which is being hosted by a group in Fairfield, part of the effort to try and educate the public on elections issues, so, with our expertise in elections issues and voter fraud we are going to do as much as we can with various organizations to educate the public and increase confidence in the electoral process.


